NEW SOUTH WALES SUPER SENIOR GOLF ASSOCIATION (Inc)

Conditions of Entry Revised 26-10-23

Condition 1. Entrance Fee.

There will be an entrance fee of \$100 to be paid by the Team Players or Club to cover Administration Costs . Entry forms that do not include the entry fee will be given until the 15th March or they will be excluded from the draw. A refund will not be available to teams that withdraw from the Pennant once the Draw is posted on the website.

Cheques can be made payable to N.S.W.S.S.G.A. (Inc) or can be deposited electronically into the account shown on the Entry Form. Please state the Club that you are paying for.

Condition 2. Green Fees.

The competition is conducted along the lines of Pennant play with no green fees on the day.

Condition 3. Type of Play.

The type of competition is single scratch match play over 18 holes. The competition is played weekdays on a day and time suitable to the host club.

Condition 4. Team Size/Scoring.

Size. Teams comprise a minimum of eight players.

Scoring. Each Player scores one point for each win. Players who halve a match will score half (1/2) point each.

Winner. In Divisional Rounds the team with highest point score is the Game winner. If both teams have the same points score after all matches have been decided then the result is a draw.

Condition 5. Divisions.

A Division where possible will comprise seven teams with neutral courses being used for the Divisional Section of the Pennant. Each Club under this concept will play six games, five games in the case of a six_team Division, and more than one course may be used to limit the tee times required at each club. In determining the composition of Divisions, cognizance will be taken of distance of travel and local needs. Where possible Clubs will be changed around annually to provide a variation in courses played.

Condition 6. Caddies

Caddies are acceptable and under the Rules of Golf are the only person that may give advice to their player. See Rule 9 in the Rules of Play for the latest advice

Condition 7. Ride on Transport.

Vehicles. Any form of Ride-on transport is allowable, subject to individual Club's policy.

Private Vehicles. Players wishing to use their own transport must obtain the Host Clubs approval and comply with any Host Club insurance requirements.

Condition 8. General.

Course Availability for Final Series. Teams that agree for their course to be used as a neutral course in the case of a 6 team Division will not be asked to provide their course for a game in the Finals. Otherwise all other teams' courses are to be made available for a game in the Finals.

The choice of a neutral golf club venue for the Grand Final will be made by the NSWSSGA(Inc) Committee reflecting the availability of the courses.

The Conditions of Entry to the Super Senior Pennant ensures that both Zone final winners are required to travel to a neutral golf club venue for the Grand Final.

Provision of Shirts and Balls. The provision of team shirts and balls to players is at the discretion of each club.

Halfway Refreshments. The Provision of Food and /or Drinks is entirely up to each individual Club.

Dress Rules. All players and caddies should be aware of, and must abide by the dress regulations of the Host Club on the course, within the Clubhouse and Pro Shop precinct.
